**ERIE METROBARK PARK RULES**

1. All dogs must be registered with Erie MetroParks and wearing the Erie MetroParks registration collar.
2. Park users must clean up after their pets.
3. Female dogs in season and puppies under 16 weeks of age are prohibited.
4. Dogs must be currently licensed and vaccinated for rabies, distemper and parvovirus.
5. Maximum of two dogs per handler.
6. Dogs must be leashed when entering or leaving the dog park.
7. Dogs showing aggressive behavior must be leashed and removed from the park immediately.
8. Users under 16 years of age must be accompanied by an adult when within the dog park.
9. Users are expected to report problems immediately to Erie MetroParks staff or a volunteer on duty at the park.
10. Glass containers are prohibited.
11. All pets other than dogs are prohibited in the dog park.
